Form I-765, Application for Employment Authorization — This is an optional form used to request permission to work in the United States. An adjustment of status applicant is eligible to request work authorization.

### **Documents to Submit with Form I-485 Package | CitizenPath**

Form I-765 can be used to request an employment authorization document (EAD), by some foreign nationals who are in the U.S. for a limited amount of time and are eligible to work. The EAD is also referred to as a work permit. Form I-765 consists of 2 page with 19 numbered blanks to fill out. Your answers should be typed on Form I-765, if possible.

### **I-765, Application for Employment Authorization**

Form I-765 is used to start an Employment Authorization Document application and for its renewal. Keep in mind that it can take 90 days or more for an Employment Authorization Document to be processed. Be careful and take your time when filling out Form I-765.

### **How to Renew an Employment Authorization Document**

Each Affidavit must include each person's full name, address, date and place of birth their relationship to you, and details of their knowledge of your relationship, include a valid form of ID for each letter of support; and. Any additional documentation that shows proof of your marriage/relationship.

### **What Supporting Documentation Must You Provide With Form I ...**

Form I-765, Application for Employment Authorization. A copy of Form I-94, non-immigrant arrival/departure record, if available. A copy of your last EAD (front and back), if available. 2 identical photographs.

### **How to file H4 EAD, Documents, Form i765 (Renewal Process)**

You will be required to provide the following documents with your Form I-864. It is acceptable to send photocopies, rather than originals of these documents. Proof of U.S. Citizenship or Residency. You must submit one of the following based on whether you are a U.S. citizen or resident: Birth certificate; Certificate of naturalization;
